## **AMENDMENT**

WHEREAS, Century Village East, Inc., is the lessor of certain DEMISED PREMISES described in the Long-Term Lease attached as Exhibit "2" to all Declarations of Condominium declared in that certain development generally known as Century Village, Deerfield Beach, Pilorida, and recorded in the Public Records of Broward County, Florida, as more particularly set forth in Schedule "A", annexed to and made a part hereof; and


